SDRM Guide

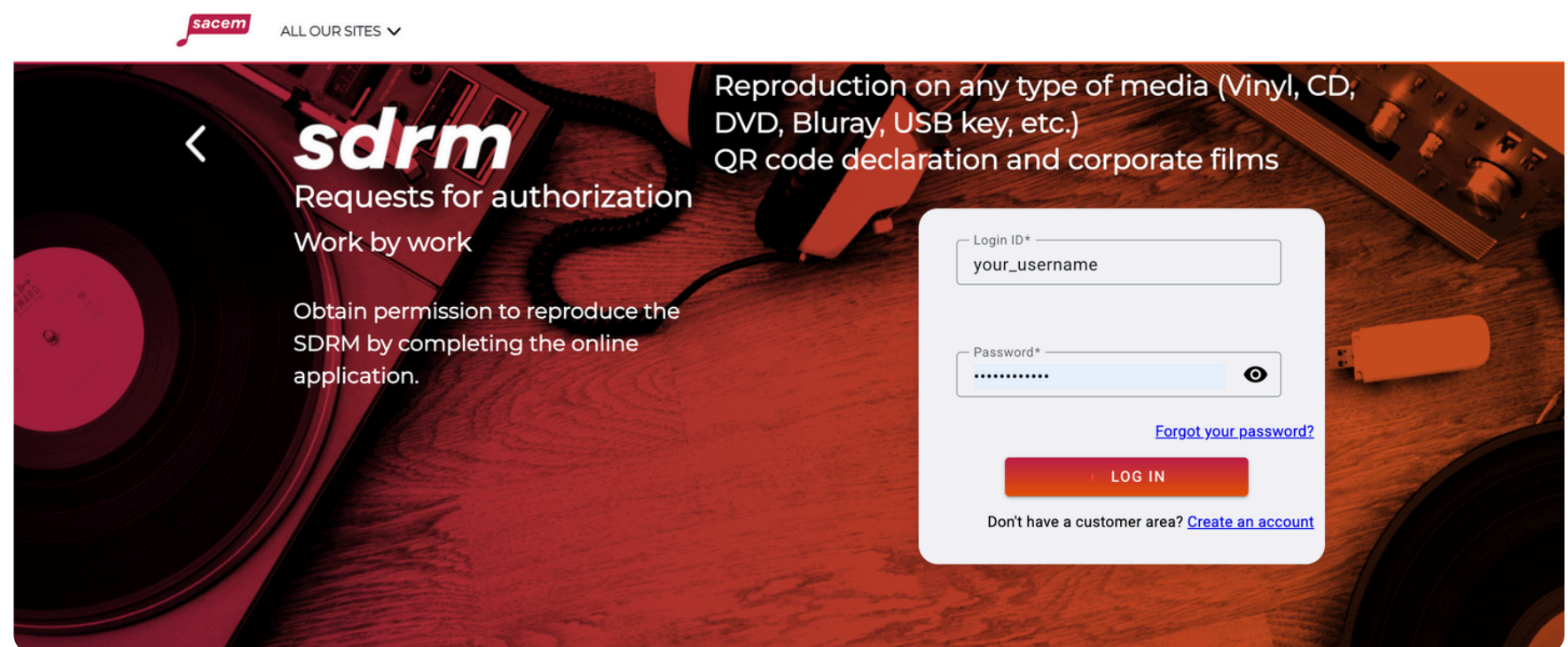
When you want to press a disc with Diggers Factory, it is necessary to submit a request to the SDRM (Société pour l'Administration du Droit de Reproduction Mécanique), a subsidiary of SACEM.

By contacting the SDRM, you fulfill your obligations towards the authors, composers, and publishers whose works you wish to reproduce.

In other words, you pay a royalty only if the tracks are part of the SACEM repertoire, so that the authors, composers, arrangers, and publishers of those tracks receive the copyright royalties owed to them.

THE AUTHORIZATION REQUEST - step 1

Once logged in, click on: FILE AN APPLICATION

You then need to fill in all the necessary information.

GENERAL INFORMATION ABOUT THE APPLICATION:

The EAN13 code corresponds to the barcode, available in the production portal under “Information” on the Diggers project page (this step is not mandatory).

- Ordering party: Yes, Company name: Diggers Factory
- Involved distributor: Yes, if the project is distributed in stores
- Box set: depends on the project

THE AUTHORIZATION REQUEST - step 2

The next step is to add the tracks:

SUPPORT INFORMATION:

→ First, click on the icon 

This action redirects to a new section divided into two parts:

This step involves filling in all the necessary information. Your reference number corresponds to the “CAT Number”, available in the production portal under “Information” on the Diggers page related to your project.

After accepting the SDRM's terms and conditions, you will have officially completed the procedure, and your request will be submitted to the SDRM.

Once the request has been processed, you will then need to pay the royalties to the SDRM, which will subsequently be redistributed to the rights holders by SACEM.

You will then upload the PDF to your project page on your Diggers Factory account.
